IPAM Virtual Panel: The First Year of Implementing the Project Accountability Policy

Introductory remarks: Victoria Marquez-Mees, Chief Accountability Officer

The Project Accountability Policy, approved in 2019 by the EBRD Board of Directors, came into effect on 1 July 2020 with the establishment of the Independent Project Accountability Mechanism (IPAM). IPAM, headed by the EBRD's Chief Accountability Officer, receives and reviews harm allegations raised by people and civil society organisations who are affected by EBRD-financed projects. This panel will review the first year of implementing IPAM through its casework. Both requesters and IPAM staff will share their insights, based on the experiences of three active cases, in order to foster discussion and participation from attendees.
