1. INTRODUCTION

The objective of this Report is to summarise the key comments received from stakeholders during the consultation period on the Bank's Strategy for Croatia and provide the Bank's management responses.

In accordance with the EBRD Access to Information Policy (AIP), the draft strategy for Croatia was posted on the EBRD website for 45 calendar days, starting from 06 December 2022. The public was invited to comment on the draft strategy no later than 12 January 2023. The previous strategy was also made available on the EBRD website at https://www.ebrd.com/croatia.html.

Information about the public consultation process was posted on the EBRD's dedicated "Have your say" webpage, which highlights the latest opportunities for the public to comment on the Bank's policies and strategies under review. Targeted notifications of the consultation process were sent to local and international civil society organisations (CSOs) that have expressed interest in the Bank's work in the country.

During the consultation period, two written comments have been received by the EBRD from an interested member of the public.

In line with the Bank's increased efforts to involve civil society at an early stage of country strategy development, the EBRD organised a consultative meeting with civil society organisations (in-person format) at the EBRD Zagreb Resident Office on 21 September 2022.

The objective of the meeting was to gather civil society's feedback during the preparatory phase for developing the draft strategy. Five CSO representatives from different civil society organisations participated in the consultation.

The EBRD was represented by the Head of Croatia, the Deputy Director for Country Strategy Coordination, as well as a Senior Banker, Regional Economist, the Country Strategy and the Civil Society Engagement teams.

The summary of the key messages and the list of CSO participants in the consultation process are provided in the Annex 1 to this Report.

EBRD Strategy for Croatia

Consultation with civil society, 21 September 2022

The civil society representatives welcomed the presentation of the country strategy and expressed their general endorsement of the three priorities (1.Supporting private sector competitiveness through digitalisation and good governance, 2.Economic inclusion and growth, and 3.Green and sustainable development), emphasising that all EBRD country strategy priority areas are well aligned with Croatia's needs from the perspective of their organisations.

In their comments, the CSOs focused mostly on private sector competitiveness, market and administrative barriers, green economy transition, increased use of renewable energy, inclusion of women, youth and other underserved segments, employment opportunities and vocational training, digitalisation and strengthening stakeholder engagement.

• Supporting private sector competitiveness through digitalisation and good governance

According to the CSO representatives, there has been significant improvement in policy engagement with the government over the last four years – particularly when it comes to renewable energy – thanks to the EBRD's involvement. Nonetheless, CSO representatives consider that the public sector lacks the proper capacity to effectively deliver public services. Good cooperation between businesses and academia has also been highlighted.

• Economic inclusion and growth

Inclusion was another important area that the CSO representatives referred to, focusing particularly on education, youth employment, as well as vocational training required to meet labour market needs and tackle the workforce deficit.

Green and sustainable development

Sustainability (nature, biodiversity, waste management) was another key area highlighted by the civic representatives. They highlighted the lack of capacity and understanding from the public sector to consider and adopt appropriate measures to address sustainability challenges. According to CSOs, there is also lack of understanding by the authorities on how to best use the EU funds from the Recovery and Resilience Plan. Rural and coastal areas are more vulnerable and lack basic infrastructure. There are also barriers when it comes to effective energy storage for households due to inadequate legislation. CSOs emphasised that very often the legislation is there, however it is not properly implemented.

Summary of key messages from CSOs:

PUBLIC

- Civil society organisations endorsed the Bank's Croatia strategy priority of supporting competitiveness through innovation, digitalisation and good governance.
 In particular, CSOs consider that the EBRD should support reforms aiming to remove market and administrative barriers for green innovation targeted at small and medium sized businesses.
- Civil society representatives further endorsed the Bank's focus on accelerating Croatia's green economy transition and its Paris alignment. CSOs welcomed the focus on increasing renewable energy capacity. However, CSOs underlined the need for green infrastructure investments in rural and coastal areas, where improvements are lagging behind.
- Civil society organisations, moreover, welcomed the Bank's strategy priority to
 increase resilience through inclusion and strengthened stakeholder engagement.
 CSOs highlighted the access to employment opportunities, skills and finance for
 underserved groups such as women, youth, refugees and other vulnerable groups, as
 an area they would like to see the Bank continue to focus.
