Name of Tenderers rejected and reasons for rejection:

Lot 1: ZAO “Alamudunenergo” was found substantially non-responsive during the detailed examination for Lot 1, mainly due to major deviations in the technical specifications for one of the goods proposed under Lot 1, the wheeled excavator. The deviations in the technical specifications are of material and non-material nature. **ECA Service** - The Power of Attorney is a copy of the Order of the Company founder in Russian on establishment of the same company for entrepreneurship. The tender is not complete, and misses plenty of documents, like financial statements, Evaluation and Qualification Forms and supporting documents in terms of financial and experience, MAF, and some others. **MEGA Service** - The validity of the tender is 30 days, however 90 days were required in the bidding documents. The whole bid is in Russian, though English language was required in bidding documents. The tenderer has explicitly omitted critical items from the scope of supply. Lot 1 is missing one of the items, like wheeled hydraulic excavator. The bid is missing all the required forms, financial documents, MAF, Power of Attorney, Evidence to be represented by an Agent in the Purchaser country for spare parts and after-sale service and etc. **JVC Tacheng Lanya Trade Co. Ltd and Narke Ltd.** - The tenderer has signed, but not stamped the Letter of Tender and has proposed the tender price in USD, though Euro was required. Except the Letter of Tender and Covenant of Integrity and Price Schedules none of the pages are signed and/or stamped. The tenderer has not submitted Joint Venture Agreement, all the required forms, financial documents, MAF, Evidence to be represented by an Agent in the Purchaser country for spare parts and after-sale service, experience supporting documents and etc.
