Duration of the contract awarded: 300 (three hundred) days starting from October 09, 2018 (start date)

Summary scope of contract awarded: Planning and construction of an administrative compound for the Batken city Taza Suu Municipal Enterprise. The compound has a two stories administration building with drinking water and wastewater test laboratory facilities, and work stations for administrative and technical staff of Taza Suu Municipal Enterprise, as well as a separate section for customers’ service. The compound also has a maintenance building with two bays and equipment storage, and parking area canopied for equipment and machineries of enterprise. The compound will also have a guard house to keep entries under control to the compound and distribution reservoir site. The land for the compound is owned by enterprise, and provides approx. 1,690 sq.m area.

“Chingyz Stroy” Ltd – Method statement, preliminary work program, financial statements for 2015 year and the Dayworks Schedule not submitted even after clarification request. Other documents provided in Russian only.

“Ideal” Ltd – Tender Forms, Method Statement, Preliminary Work Program, Equipment list, Dayworks Schedule and Covenant of Integrity were not submitted. Other documents provided in Russian only.
