EXECUTIVE SUMMARY

This is the annual report on the procurement activities of the Bank carried out under the Corporate Procurement Policy.

Following the review of the Corporate Procurement Policy and the Procurement Policy and Rules in October 2017, procurement activities were realigned, with all procurement of goods, works and services contracted by the Bank being covered by the Corporate Procurement Policy. Any procurement of goods, works, services and consultancy services contracted by the Bank's clients is covered by the Procurement Policy & Rules and a separate report is prepared for procurement of these activities.

To allow a meaningful comparison of the 2017 Bank contracted data presented by PODD with the data previously reported by the Technical Cooperation (TC) team, the TC team's statistics for 2013 – 2016 have been adjusted to exclude consultancy contracts awarded by the Bank's clients (funded either through donor Technical Cooperation (TC) funds or public sector loan proceeds) that were previously included in the annual reports prepared by the TC team.

Consultancy Services Supporting Projects

- Following this adjustment, the overall conclusion is that the value and number of consultancy contract awards by EBRD in 2017 was at a similar level to 2016. In 2017, there were 2,877 consultancy contracts awarded with a total value EUR 129.06 million, compared to 2,863 contracts totalling EUR 129.54 million in 2016, showing less than 1% variation.
- In 2017, 73% of the value of the Bank contracted assignments were funded through various Donor TC funds programmes and agreements, compared to 70% in 2016.
- Increase in use of Donor funds reported by TC team the previous year continued in 2017, with EUR 94.40 million of Donor TC funds utilised to award 1,617 consultancy contracts), representing a 4.5% increase in value of contracted TC Donor funds compared to 2016 when EUR 90.32 million of Donor TC funds were contracted by the Bank (1,636 contracts).
- In 2017, competitive selection methods were used to award 56% by value of the consultancy contracts awarded by TC Team/PODD (EUR 111 million).

Goods, Works and Services including Consultancy Services for Corporate Purposes

- In 2017 corporate procurement expenditure was GBP 70,641,948, matching the 2016 total of GBP 70,646,000.
- Over 40% of the Bank's corporate procurement expenditure in 2017 was disbursed via contracts with twenty suppliers.
- Seventeen of the twenty suppliers were contracted following a competitive procurement process. One of the suppliers directly engaged, a major professional services firm, was

awarded three contracts, one of which was awarded competitively (International Financial Reporting Standard (IFRS) 9 Implementation Services).

- Of the three directly engaged suppliers, the major professional services firm was engaged directly in order to maintain continuity following the competitive award of the contract to review the Bank's project life cycle and budget processes.
- The remaining two directly awarded suppliers have been engaged as long-standing exceptions to competitive procurement on the grounds that they provide a service or software that is currently uniquely capable of responding to the Bank's needs.
- In 2017, competitively awarded contracts and extensions made up 55% of total contract value. This is a decrease from the same figure for 2016 of circa 70%. However, the drop is due to the direct award of a single high-value contract extension. Excluding this exceptional direct award the percentage of contracts and extensions competitively awarded in 2017 rises to the 2016 figure of 70%.

1 Introduction

The Annual Bank Procurement Review (the “Report”) provides an overview of the procurement activities of the European Bank for Reconstruction and Development (the “EBRD” or the “Bank”) in procuring the goods, works and services including consultancy services contracted by the Bank.

Following the review of the Corporate Procurement Policy and the Procurement Policy and Rules in October 2017, procurement activities were realigned, with all procurement of goods, works and services contracted by the Bank being subject to the Corporate Procurement Policy. Any procurement of goods, works, services and consultancy services contracted by the Bank’s clients is covered by the Procurement Policy & Rules and a separate report is prepared for procurement of these activities.

The two sections of the Report provide an overview of procurement activities relating to: (1) consultancy services required by the Bank in support of its projects; and (2) goods, works and services including consultancy services required for corporate purposes.

Following review by the Audit Committee, and in accordance with the Bank’s Public Information Policy, the Report will be published on the Bank’s website.¹

2 Consultancy Contract Awards

In 2017, the Bank entered into **2,877 consultancy contracts totalling EUR 129.06 million**. This is consistent with the procurement activity in 2016 when 2,863 consultancy contracts awarded for a total value of EUR 129.5 million.

The Table shows the split in the values and numbers of contracts.

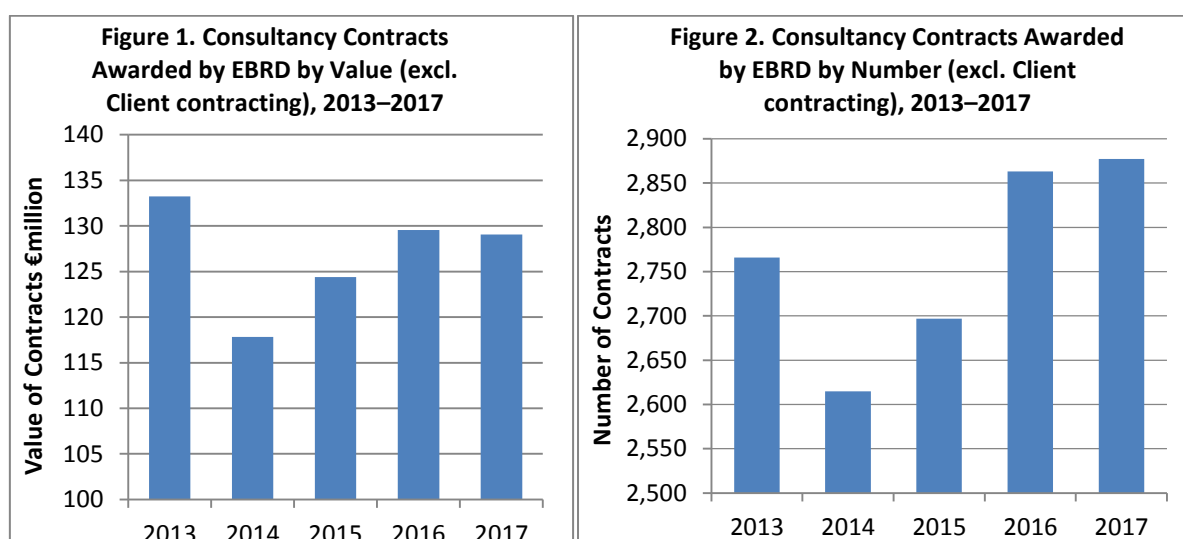

The Figures below present the value and number of consultancy contract awards (excluding contracts signed by the clients previously included in the Annual Reports on Engagement of Consultants) in the past five years.



In 2017, 73% of the contracts funded through various Donor TC funds programmes and agreements, compared to 70% in 2016. EBRD’s Annual Donor Reports prepared by the Donor Co-Financing (“DCF”) team provide a comprehensive review of the donors’ TC funding.

3 Consultant Selection

3.1 Selection Methods

In 2017, competitive selection methods were used to award 56% by value of the consultancy contracts signed by the Bank (EUR 111 million).

The Table below shows the breakdown by selection method for such consultancy contract awards.

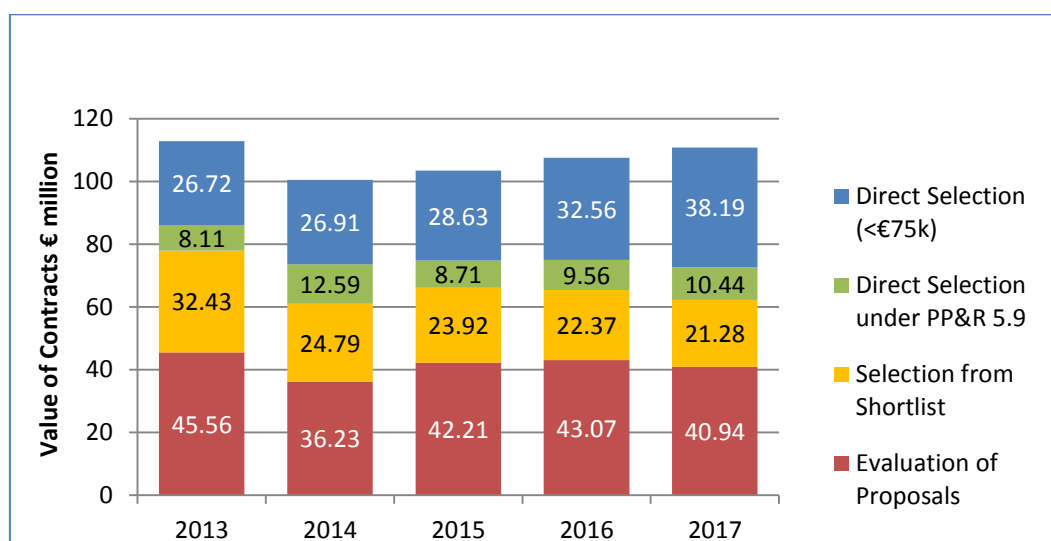

3.2 Engagement of Consultants by PODD

In 2017 the number and value of consultancy contracts other than law firms amounted to 2,215 and EUR 110.86 million respectively. In 2016, TC Team reported the selection and engagement of 2,257 contracts, with a total value of EUR 146.7 million, including 124 consultancy contracts totalling EUR 39.1 million signed by the Bank’s clients under the grant agreement structure. When comparing the 2017 data with 2016 on a like-for-like basis (i.e. excluding grant agreements with clients), the number of consultancy contracts signed by EBRD increased by 0.49%, and the value decreased by 0.38%. The distribution of value of contract awards by selection method for the past five years is presented in Figure 3 overleaf.

3.2.1 Consultants Contracted as Individuals In 2017 out of 848 contracts with a total value of EUR 19.85 million awarded to consultants contracted as individuals, 76% by value were awarded through direct selection. This is comparable to 2016 when TC Team reported 68% by value of the contracts awarded by direct selection including 13% awarded under section 5.9 of PP&R (which applied to these contracts until 1 October 2017).

3.2.2 Consultants Contracted as Firms EBRD contracts a large number of consulting firms to support its TC and operational needs. The use of competitive selection methods with consulting firms is higher with 63% by value of contracts for firms being awarded following competitive processes (45% by value of contracts were awarded as Evaluation of Proposals, which is the most competitive method).

3.3 Engagement of Law firms

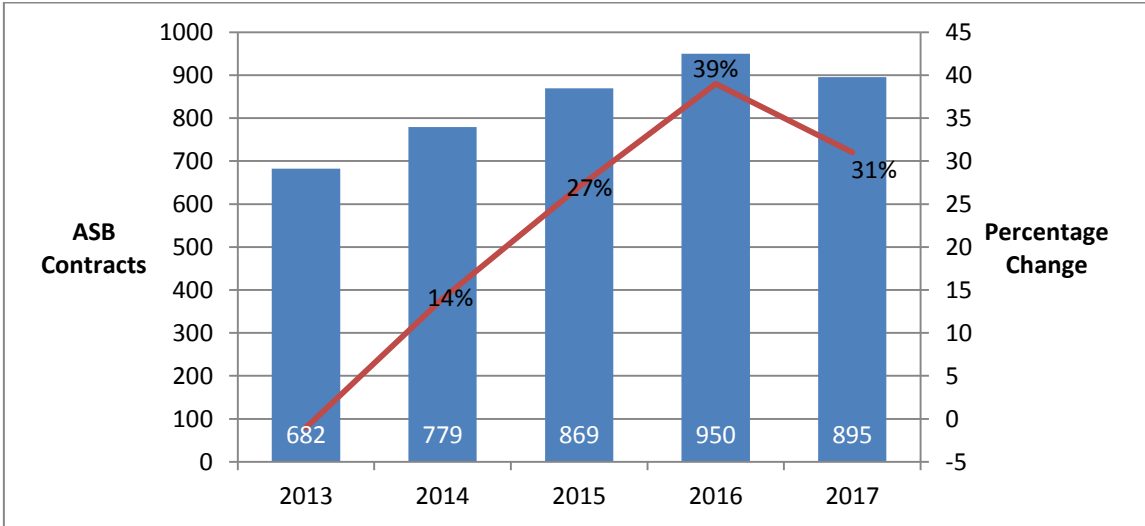
In 2017, the Bank entered into 662 contracts with law firms totalling EUR 18.2 million which was a decrease compared to 2016, when the Bank awarded 730 contracts totalling EUR 22 million. Engagements include services for corporate purposes as well as support for banking and treasury operations. Costs incurred by the Bank in relation to banking projects are typically reimbursed by the client.

3.4 Advice for Small Businesses (“ASB”)²

In 2017, a total of 895 ASB contracts for EUR 13.5 million were awarded including contracts for the International Advisory (“IA”) Advisory and Team Coordinators, and Market Development Activities consultants. As most ASB contracts were within the direct selection threshold, this method was used for more than 90% of contracts (EUR 12.09 million) with the balance of contracts selected from a shortlist. In 2016, by comparison, a total of 950 contracts for EUR 11.7 million were awarded for ASB, with 97% of the value of contracts (EUR 11.3 million) awarded directly and the balance of contracts selected from shortlist.

With the exception of contracts issued to consultants for Local Consultancy (formerly Business Advisory Services) projects, PODD is now responsible for the engagement of consultants for ASB activities. Table 5 shows the number of ASB contracts issued from 2013 onwards and also plots the percentage change in comparison to 2013³. Numbers of contracts issued have risen steeply in the five years to 2016, with the number of contracts issued in 2017 increasing by 31% relative to the number issued in 2013.

4 Consultancy Contracting Type

4.1 Overview

In 2017 standard (stand-alone) contracts accounted for almost 83% of the number (1,830 contracts) and 76% of the value (EUR 84.78 million) of all contract awards. 10 framework contracts totalling EUR 11.19 million (10%) were awarded, with further 55 framework agreements with zero value but carrying a potential value in excess of EUR 20 million (see Section 4.2 on framework contracts and agreements). 320 call-off notices under the existing framework agreements accounted for 14% of the value of all contracted assignments (EUR 14.89 million).

4.2 Framework Contracts and Framework Agreements

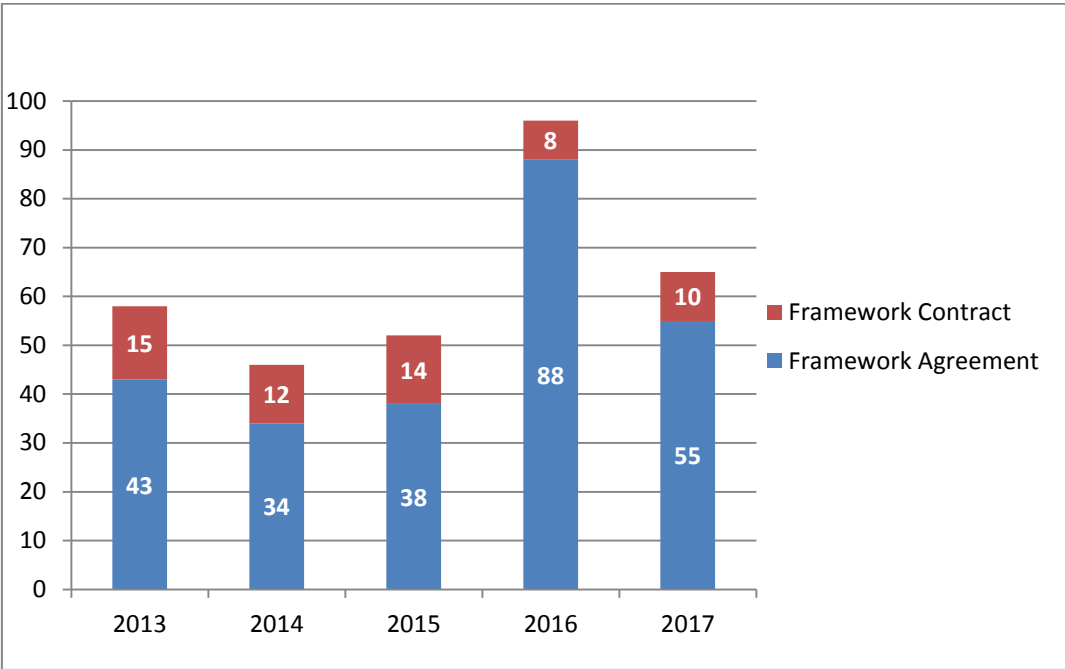
Framework Contracts and Framework Agreements are used by the Bank as instruments for retention of consultants for repetitive, similar assignments requiring the same expertise. Following competitive selection, consultants are awarded framework contracts or agreements with broad terms of reference defining the nature and scope of the services required. The use of frameworks enables procurement to be carried out earlier, facilitating rapid consultant mobilisation once specific service requirements are finalised, and provides an efficient contracting instrument. The key distinction between a framework agreement and a framework contract is that the framework agreement does not have a committed budget (ceiling on value) when the framework agreement is entered into.

Framework consultants are only mobilised as and when the Bank identifies the requirement for a specific assignment and awards a call-off notice (either directly or following evaluation of proposals submitted by consultants with framework agreements) which contains the specific terms of reference and budget for the assignment. Framework Agreements permit the rapid mobilisation of consultants which bring efficiency gains.

The number of frameworks issued by EBRD over the past five years has been broadly consistent with recent years⁴.

Among the 55 framework agreements awarded in 2017, 20 were pre-qualification panel agreements whereby the Bank selected and retained firms for provision of standardised services (such as corporate development programmes and project implementation support) funded by grants.

In 2017, there were 320 call-offs awarded under existing Framework agreements (an increase compared to 236 in the previous year) totalling EUR 14.89 million (EUR 17.7 in 2016). Out of 320 call-offs, 76 with a total value of EUR 9.54 million were awarded following competitive selection process among the framework agreement holders, with the remaining 244 call-off totalling EUR 5.35 million awarded directly to preferred consultants with framework agreements, without secondary competition, either because individual assignments were below the EUR 75K threshold or justified under Section 5.9 of the Bank’s PP&R (which applied to these contracts until 1 October 2017). The competitively awarded call-offs included 15 assignments with a total value of EUR 5.5 million contracted under the Infrastructure Project Preparation Facility (IPPF) which has been designed by the Bank in the context of an international push to accelerate infrastructure investment and allocated EUR 40 million from Bank net income under the Shareholder Special Fund.

Section 2: Procurement of Goods, Works, Services for Corporate Purposes.

5 Corporate Procurement

Total corporate procurement expenditure (excluding expenditure by the ROs) in **2017** was **GBP 70,641,948 which is in-line with the 2016 total of GBP 70,646,000**. Expenditure in previous years was as follows: **GBP 44,785,376 (2013), GBP 54,367,703 (2014), GBP 85,203,365 (2015) and GBP 70,646,000 (2016)**. Table 7 (below, page 15) lists the categories in order of the amount paid by the Bank in 2017. Consultancy, IT Software, Information Services and Telecommunications accounted for over 50% of the Headquarters' Corporate Procurement expenditure in 2017.

The Bank's reported expenditure on **Consultancy Services (other than from law firms)** in 2017 remained at the same level as for 2016. Project specific consultancy expenditure was comparatively high in 2017 including the contract for the implementation of the **IFRS 9 project (GBP 1.5 million), and support to the Bank's operational effectiveness and efficiency programme GBP 1.7 million**.

The remaining 82% (GBP 15.9 million) of the consultancy expenditure relates to advice and support for IT projects and the IT Department itself (a reduction from the 2016 total of GBP 17.6 million).

The **IT Software** category consists of software licences and the associated on-going support costs. Circa 60% of the expenditure was for the provision of specialist software required for the delivery of the IFRS 9 project.

Information Services covers all forms of business and technical data purchased from vendors of information services. Most of the contracts awarded in this area are subject to sole source approval as these data services are usually of a unique nature and there are few, if any, opportunities for competitive tendering.

Telecommunications covers data network services, mobile and landline telecommunications. The Bank's expenditure on mobile telephony remained at a similar level to the 2016 figures (GBP 1.17 million in 2017 and GBP 1.33 million in 2016). The increase in expenditure in this category for 2017 compared to 2016 is predominantly due to expenditure on the WAN Upgrade contract (GBP 1.6 million)

IT Services consists of significant contracts for the provision of specific technical support for the Bank's main IT infrastructure and business continuity services. Competitively awarded contracts with fixed and competitive pricing make up approximately 85% of this category: (i) provision of the Bank's helpdesk; (ii) business continuity services; and (iii) specialist system development services.

Almost the entire **Catering and Hospitality** category (98%) is covered by the contract to provide catering services at the Bank's HQ. The contract was tendered in 2011 and a new caterer engaged as a result in December 2011. The contract covers the cost of operating the Mozart Restaurant, the Executive Dining Room and Coffee Bar including the cost of food, beverages and necessary supplies. The figure quoted covers the amount spent by the Bank however it is moderated by cash receipts received via staff catering cards amounting to GBP 1,359,766 in 2017.

Employee Benefits expenditure in 2017 includes specialised services required to operate the Retirement Plan (70%) and the preferential corporate gym membership (20%).

Building Maintenance includes all forms of maintenance for Headquarters including mechanical/electrical and fabric maintenance representing circa 50% of the total spend in 2017 (GBP 1.3 million) and cleaning services representing circa 35% of the total spend in 2017 (GBP 0.86 million).

IT Hardware includes the cost of purchasing hardware and its maintenance including managed firewall services (GBP 484,270) and server maintenance (GBP 156,668 in 2017).

Security expenditure is predominantly made up of manned guarding services (over 60%). A new provider of Manned Guarding Services for the HQ was contracted in 2014 following a tender process (GBP 5,303,352.50 over a period of 5 years).

Buildings (HQ and RO) Related includes the works on level two of Headquarters (GBP 1.17 million).

Freight and Removals services are provided for almost entirely via the contract awarded in 2014 to provide relocation and removal services. This contract was retendered in 2017.

Expenditure in the **Training Courses** category increased in 2017 compared to 2016. The increase in 2017 was driven by the Bank's investment in new training courses, specifically in relation to management training.

Utilities expenditure for the Bank's Headquarters in 2017 was split as follows: Electricity GBP 1.45 million and gas GBP 116,040.

Recruitment Services are provided via a range of framework contracts for the recruitment of permanent and temporary staff at both the support and professional level. 60% of the expenditure in this category during 2017 was made with Resource Solutions under the contract retendered in 2016 (GBP 0.8 million in 2017).

Insurance includes commercial, vehicle, medical, personal and travel insurance with approximately 99% of the category total paid via the Bank's contract with its competitively selected broker.

The Bank's Annual Meeting Event Management specialist (GBP 290,632), Equipment hire for the Annual Meeting (GBP 74,074), the art and design specialist for the Annual Meeting (GBP 136,832), and partnership with the World Economic Forum (GBP 0.3 million) make up over 50% of the **Events** category.

Reprographics and Document Recording include the services of design agencies, printing firms and the in-house print room facilities which are predominantly provided via competitively awarded contracts.

Furniture and Building Equipment includes expenditure for Headquarters and Resident Offices. The major part of Headquarters' furniture is purchased under a framework contract competitively awarded in 2010 with the rates negotiated at the same (2010 rates) until the end of 2018.

Health and Safety consists of medical services, protective clothing and ergonomic equipment. Approximately 80% of the expenditure was made for medical services.

Auditing Services are provided by the Bank's external auditor, selected following a competitive procurement process.

The **Travel Agency** category is made-up of:

(i) Business travel agency services. The introduction of a new on-line booking tool and the move from a management fee to a transaction fee business model following a change in supplier in June 2015 reduced the Bank's travel agency costs. The cost increase between 2016 and 2017 in transaction fees (GBP 190,024 in 2016 and GBP 290,161 in 2017) is the result of higher volumes of transactions. The contract with the Travel agent provides for a reduction in the transaction fees as the volume of transactions increases.

(ii) Event management services. The Bank reduced its expenditure in this area mainly due to a reduction in the number of team retreats. The event management service provider does not charge the Bank for its service (commissions are paid to the event management service provider by the venues). In addition to the operational efficiency gains generated, the event management service provider delivers an average 21% cost saving for the Bank by negotiating preferential rates with venues.

Other Outsourced Services includes specialised design services and HR support services making up 55% of the costs. The balance of the expenditure was via POs or contracts with “one-off” service providers.

Transport Services consist mainly of taxi services making up more than 70% of the total expenditure in 2017.

Mail and Courier services are bought from courier services with a major courier company representing the largest share of the total at 77 % of the category total, the balance relates to the UK postal service and local couriers.

6 Management of the Bank’s Suppliers

Almost half of the 933 suppliers paid by the Bank in 2017 were engaged using a contract as opposed to a standalone PO. Contracts provide for a longer-term relationship with a supplier than a PO which is a legally binding agreement that is typically used for one-off requirements.

The percentage of total expenditure under contract remained high in 2017 at 93% (95% in 2016 & 2015, 93% in 2014 and 92.5% for 2013). By utilising contracts the Bank optimises its commercial leverage and builds more effective relationships with its suppliers.

The use of standalone POs is an efficient and legally secure manner in which to procure one-off requirements. Approximately 50% of the total expenditure using standalone POs relates to the procurement of IT Hardware from IT resellers.

7 The Bank's Top Twenty Corporate Procurement Suppliers (by value)

The Bank has optimised its procurement and contracting strategy for complex and high value contracts, the results of which are as follows:

- Over 40% of the Bank's corporate procurement expenditure in 2017 was disbursed via contracts with twenty suppliers.
- Seventeen of the twenty suppliers were contracted following a competitive procurement process. One of the suppliers directly engaged, a major professional services firm, was awarded three contracts, one of which was awarded competitively (IFRS 9 Implementation Services).
- Of the three directly engaged suppliers, the major professional services firm was engaged directly in order to maintain continuity following the competitive award of the contract to review the Bank's project life cycle and budget processes.

- The remaining two directly awarded suppliers have been engaged as long-standing exceptions to competitive procurement on the grounds that they provide a service or software that is currently uniquely capable of responding to the Bank's needs.

8 Contracts Awarded in 2017

The total number of contracts issued in 2017 decreased when compared to the volume and value issued in 2016 but the total value increased comparatively. Since 2009 the trend in the overall number and value of contracts awarded has been upward. This is explained by the investments made by the Bank in its infrastructure, new initiatives and the expanded remit of the CPP following its update in January 2014.

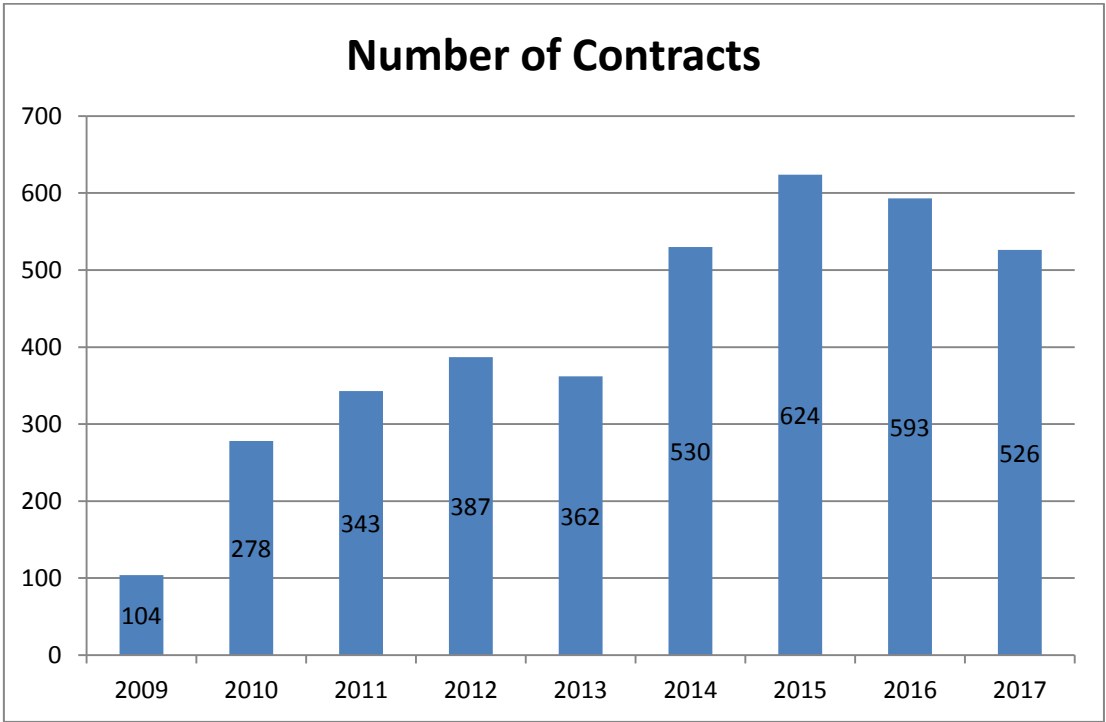
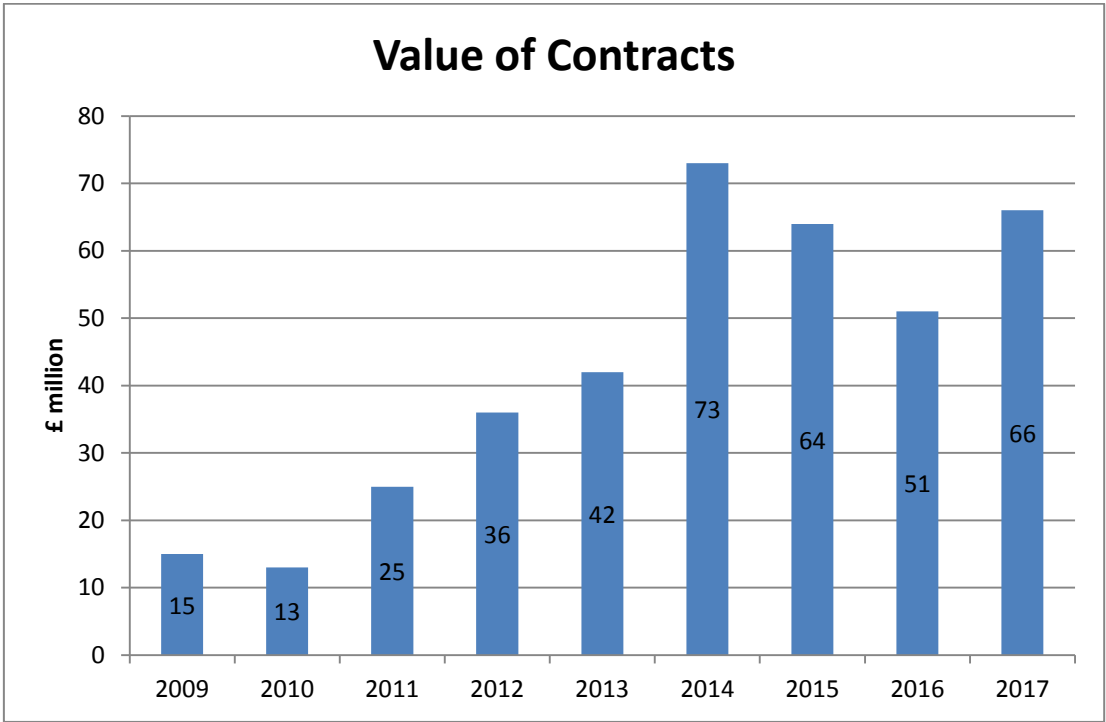

Competitively Awarded Contracts

In 2017 competitively awarded contracts and extensions made-up 55% of the total value of contracts awarded. Competitively awarded contracts often provide for an extension subject to the performance of the supplier and the Bank's requirements. The competitive procurement process followed at the outset to award all such contracts assumes the maximum contract duration and value including all potential extensions. The Table below shows the distribution of contracts by method of award (direct or competitive) and by value.

Directly Awarded Contracts and Extensions

The direct award of contracts is permitted for contracts estimated to cost less than GBP 5,000 (increased to GBP 10,000 from 1 October 2017). For contracts estimated to cost more than GBP 5,000 competitive procurement is required unless an exception to competitive procurement is approved. The large increase in the value of directly awarded extensions is explained by the significant contract extension negotiated with the Bank's life insurance company for a value of GBP 14 million over a five year term (2017 to 2022). The contract to

provide Group Life insurance and Working Incapacity insurance was awarded in 2011 following an extensive search for an appropriate provider. Given the specific requirements of the EBRD the contract was awarded directly to the chosen provider on the grounds that it was the only viable provider of the services required. The same market search in 2017 reached the same conclusion.

To ensure value for money the Bank engaged a major advisory, broking and solutions company in February 2017 to perform an in-house actuarial modelling/benchmark exercise. The results of the company's analysis showed that the renewal rates quoted by the Bank's life insurance company with regards to the working incapacity benefit were competitive (GBP 1 million lower than company's in-house modelling). However, the report also identified that there could be greater opportunity for cost savings with regard to the group life renewal terms. HR and Corporate Procurement negotiated with the life insurance company to achieve a revised offer providing a 33% saving and a fixed price for a period of 5 years (backdated to 1 April 2017). The advisory, broking and solutions company confirmed that the pricing was in line with its benchmark and that a five year fixed-price contract represents a highly competitive proposal.

The savings on Group Life insurance total **GBP 0.6 million** a year and **GBP 3 million** over the five year term of the contract extension.

Exceptions to Competitive Procurement

In 2017 the value of exceptions to competitive procurement was higher than for previous years with a total cumulative value of GBP 27.9 million compared to the 2016 figure of GBP 14.1 million. This rise is due to the award of the contract extension to the Bank's life insurance company (as described above) with a value of GBP 14 million.

Over 80% of the exceptions related to contracts for on-going and previously approved exceptions which is slightly higher than the figure for 2016 (75%).

9. Procurement by the Bank's Resident Offices

In 2017, the corporate procurement expenditure by the ROs amounted to GBP 2,946,301 compared with GBP 2,984,176 in 2016. These figures exclude office rent⁵ and include the costs of office maintenance⁶, cleaning, service charges⁷, vehicle running costs and items of office equipment such as printers and scanners, stationery, minor repairs. In sourcing works, goods and services for the ROs' needs, preference is given to local suppliers.

The expenditure totals exclude the cost of items purchased for the ROs using the centrally managed budget held by the Administrative Services and IT Departments.

In accordance with the Guidelines on Corporate Procurement in Resident Offices (issued in September 2011), when purchasing goods, works or services with a value of less than GBP 5,000 (or equivalent in local currency), the Bank will normally use the terms provided by the supplier to ensure that the procurement process can be concluded quickly and efficiently to avoid any operational disruptions.

⁵ Leases of Headquarters and ROs are excluded from the Bank's CPP which apply to goods, works and services whereas lease is classified as neither of these and as such is outside the scope of the CPP.

⁶ Extent of maintenance required varies under individual leases and may include air conditioning units, UPS, central heating system, generators, fire alarms, security equipment, photocopiers, and non-mechanical items such as carpets, windows, internal and external decoration, gardens and landscaped areas, gutters and rainwater down-pipes.

⁷ Payment of service charges is the direct responsibility of the ROs and is made locally whenever possible.
