As defined by Fitch, an "AAA" rating denotes the lowest expectation of credit risk and means that the Issuer has an exceptionally strong capacity for timely payment of its financial commitments.

## ANNEX

### Calculation of Interest Amount per Calculation Amount, Early Redemption Amount per Calculation Amount and Final Redemption Amount per Calculation Amount

The Final Redemption Amount per Calculation Amount or the Early Redemption Amount per Calculation Amount will be payable in USD on the Maturity Date or the Early Redemption Date as applicable, and determined by the Calculation Agent on the corresponding Rate Fixing Date as follows, rounded up to the nearest cent (with USD 0.5 being rounded up):

$$\text{Calculation Amount} \times (1/\text{Reference Rate on the applicable Rate Fixing Date})$$

In order to obtain the Final Redemption Amount or the Early Redemption Amount, as applicable, the above amount shall be multiplied by N.

The Interest Amount per Calculation Amount will be payable in USD on each Fixed Interest Date and determined by the Calculation Agent, on the corresponding Rate Fixing Date as follows, rounded up to the nearest cent (with USD 0.5 being rounded up):

$$\text{Interest Amount} \times (1/\text{Reference Rate on the applicable Rate Fixing Date}) \times \text{Day Count Fraction}$$

The Interest Amount shall then be calculated by multiplying the above amount by N.

The Calculation Agent shall notify the Issuer and the Agent (who will in turn inform the Noteholders) of its determination of the Final Redemption Amount per Calculation Amount, the Early Redemption Amount per Calculation Amount and Interest Amount per Calculation Amount payable on the Maturity Date, the Early Redemption Date and/or relevant Fixed Interest Date (as applicable), as soon as practicable after such determination (but in no event later than four (4) Business Days prior to the Maturity Date, Early Redemption Date and/or relevant Fixed Interest Date (as applicable)).

If the Reference Rate is not available for any reason on the State Bank of Pakistan website ([www.sbp.org.pk](http://www.sbp.org.pk)) or on any successor website or page on any Rate Fixing Date, then the Calculation Agent shall determine that a price source disruption event (a **"Price Source Disruption Event"**) has occurred, and shall promptly inform the Issuer and Agent (who will in turn inform the Noteholders) of such occurrence. Following the determination of the occurrence of a Price Source Disruption Event, Noteholders will not be entitled to any amounts in respect of the Notes until the earlier to occur of (i) the day falling five (5) Business Days after the day on which the Issuer is notified by the Calculation Agent that a Price Source Disruption Event no longer subsists and (ii) the Postponed Fixed Interest Date (as defined below), the Postponed Early Redemption Date (as defined below) or the Postponed Maturity Date (as defined below), as the case may be.

If on the tenth (10th) Business Day following the original Rate Fixing Date the Reference Rate as published on the State Bank of Pakistan website ([www.sbp.org.pk](http://www.sbp.org.pk)), or any successor website or page is still unavailable then the Reference Rate shall be the average of such firm quotes (expressed as the number of PKR per one USD) from three (3) Reference Dealers (as defined below) as the Calculation Agent is able to obtain for the sale of PKR and the purchase of USD at or about 2.30 p.m., Karachi time on the applicable Rate Fixing Date for settlement two Karachi Business Days thereafter, provided, however, that if fewer than three (3) (but at least two (2)) Reference Dealers provide such firm quotes then the average of the quotes actually obtained shall apply.

If none, or only one, of the Reference Dealers provides such a firm quote the Calculation Agent will determine the Reference Rate in good faith and in a commercially reasonable manner.

For the purposes of these provisions:

**"Business Day"** means any day on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealings in foreign exchange and foreign



currency deposits) in the business centre(s) specified or, if no business centre is specified, in London, New York City, Singapore and Karachi.

**"Calculation Agent"** means Standard Chartered Bank in accordance with the provisions of the Calculation Agency Agreement entered into between the Issuer and the Calculation Agent on 31 January 2020 (as amended and/or supplemented from time to time). All references to the Calculation Agent shall include any successor or successors to Standard Chartered Bank as Calculation Agent in respect of the Notes. The determination by the Calculation Agent of any amount or of any state of affairs, circumstance, event or other matter, or the formation of any opinion or the exercise of any discretion required or permitted to be determined, formed or exercised by the Calculation Agent under the Notes and pursuant to the Calculation Agency Agreement shall (in the absence of manifest error) be final and binding on all parties (including, but not limited to, the Issuer and the Noteholders) and shall be made in its sole discretion in good faith and in a commercially reasonable manner in accordance with the Calculation Agency Agreement. In performing its duties under the Notes, the Calculation Agent shall act in accordance with the Calculation Agency Agreement.

**"Early Redemption Date"** means the date on which the Notes become due and payable pursuant to Conditions 5(d) and 9.

**"Karachi Business Day"** means a day on which commercial banks are open for business including dealings in foreign exchange in accordance with the market practice of the foreign exchange market in Karachi.

**"N"** means the number resulting from the division of the Nominal Amount by the Calculation Amount;

**"Postponed Early Redemption Date"** means the tenth (10th) Business Day following the Early Redemption Date (if any).

**"Postponed Fixed Interest Date"** means the tenth (10th) Business Day following the originally scheduled Fixed Interest Date.

**"Postponed Maturity Date"** means the tenth (10th) Business Day following the originally scheduled Maturity Date.

**"Rate Fixing Date"** means the date which is five (5) Business Days prior to the each of the applicable Fixed Interest Date, Maturity Date or Early Redemption Date (if any). If a Price Source Disruption Event occurs or otherwise subsists on such day, the Rate Fixing Date shall be the earlier of (i) the Business Day on which the Issuer is notified by the Calculation Agent that a Price Source Disruption Event no longer subsists and (ii) the tenth (10th) Business Day following the original Rate Fixing Date.

**"Reference Dealers"** means leading dealers, banks or banking corporations which regularly deal in the USD/PKR exchange market, as selected by the Calculation Agent in its sole discretion, acting in good faith and in a commercially reasonable manner.

**"Reference Rate"** means the USD PKR rate expressed as the amount of PKR per one USD, for settlement in two (2) Karachi Business Days as published by the State Bank of Pakistan on its website ([www.sbp.org.pk](http://www.sbp.org.pk)), as "M2M Revaluation Rate" (or on any successor website or page or such other page or service as may replace any such page for the purposes of displaying the USD/PKR reference rate reference rate selected as the EMTA market standard), on or about 2:30 p.m. Karachi local time on each Rate Fixing Date.
