

## **MiFID II product governance / Professional investors and ECPs only target market:**

Solely for the purposes of the manufacturer's product approval process, the target market assessment in respect of the Notes has led to the conclusion that: (i) the target market for the Notes is eligible counterparties and professional clients only, each as defined in Directive 2014/65/EU (as amended, "MiFID II"); and (ii) all channels for distribution of the Notes to eligible counterparties and professional clients are appropriate. Any person subsequently offering, selling or recommending the Notes (a "distributor") should take into consideration the manufacturer's target market assessment; however, a distributor subject to MiFID II is responsible for undertaking its own target market assessment in respect of the Notes (by either adopting or refining the manufacturer's target market assessment) and determining appropriate distribution channels.

**Kyrgyz Som Exchange Risk**

The Final Redemption Amount, Early Redemption Amount (if applicable) and the Interest Amounts on the Notes are linked to Kyrgyz Som, the lawful currency of the Kyrgyz Republic ("**KGS**"). Currency exchange rates may be volatile and will affect the return to the holder of the Notes. The Government of the Kyrgyz Republic can from time to time intervene in the foreign exchange market. These interventions or other governmental actions could adversely affect the value of the Notes in USD, as well as the actual yield (in USD terms) on the Notes and the amounts payable on the Notes. Even in the absence of governmental action directly affecting currency exchange rates, political or economic developments in the Kyrgyz Republic or elsewhere could lead to significant and sudden changes in the exchange rate between KGS and USD.

**Notes are Not Liquid Instruments**

There may exist at times only limited markets for the Notes resulting in low or non-existent volumes of trading in the Notes, and therefore a lack of liquidity and price volatility of the Notes.

The Issuer and/or its debt obligations have been assigned an AAA credit rating from S&P Global Ratings Europe Limited ("**S&P**"), an Aaa credit rating from Moody's Investors Service Ltd. ("**Moody's**") and an AAA credit rating from Fitch Ratings Ltd. ("**Fitch**"). As defined by S&P, an "AAA" rating means that the ability of the Issuer to meet its financial commitment on its obligations is extremely strong. As defined by Moody's, an "Aaa" rating means that the Issuer's ability to meet its financial obligations is judged to be of the highest quality, with minimal credit risk. As defined by Fitch, an "AAA" rating denotes the lowest expectation of credit risk and means that the Issuer has an exceptionally strong capacity for timely payment of its financial commitments.

### **Calculation of Interest Amount, Early Redemption Amount and Final Redemption Amount**

The Final Redemption Amount or the Early Redemption Amount (if any), as applicable, per Calculation Amount will be payable in USD on the Maturity Date or the Early Redemption Date (if any), as applicable, and will be determined by the Calculation Agent on the relevant Rate Fixing Date, as follows, rounded up to the nearest cent:

Reference KGS Amount *divided by* the Exchange Reference Rate.

The Interest Amount per Calculation Amount will be payable in USD on the corresponding Fixed Interest Date and will be calculated by the Calculation Agent as follows, on the relevant Rate Fixing Date, rounded up to the nearest cent:

(Fixed Rate of Interest x Reference KGS Amount x Fixed Day Count Fraction) *divided by* the Exchange Reference Rate.

The Calculation Agent shall notify the Issuer and the Agent (who will in turn inform the Noteholders) of its determination of the relevant Exchange Reference Rate as soon as practicable after such determination on the relevant Rate Fixing Date (but in no event later than the Business Day immediately prior to each Fixed Interest Date, the Maturity Date or the Early Redemption Date, as applicable). If neither the Exchange Reference Rate published by the National Bank of the Kyrgyz Republic or by Bloomberg, nor the USD/KGS Bloomberg close (CMPL) is available on the Rate Fixing Date, the Calculation Agent shall immediately inform the Issuer and the Agent of such an occurrence.

The Calculation Agent shall notify the Issuer and the Agent (who will in turn inform the Noteholders) of its determination of the Final Redemption Amount, the Early Redemption Amount (if any) and the Interest Amount payable per Calculation Amount on the Maturity Date, Early Redemption Date (if any) or relevant Fixed Interest Date (as applicable), as soon as practicable after such determination (but in no event later than one Business Day prior to the Maturity Date, Early Redemption Date (if any) and/or relevant Fixed Interest Date, as applicable).

### **Disruption Event Provisions**

If the Exchange Reference Rate is not available for any reason on any Rate Fixing Date, then the Calculation Agent shall determine that a price source disruption event (a "**Price Source Disruption Event**") has occurred, and shall promptly inform the Issuer and the Agent (who will in turn inform the Noteholders) of such an occurrence.

The Calculation Agent shall then determine the Exchange Reference Rate on the next Business Day on the following basis:

- (i) The Exchange Reference Rate shall be USD/KGS Bloomberg close (CMPL) where "USD/KGS Bloomberg close (CMPL)" means the USD/KGS Bloomberg close mid-rate (Composite London)(or any successor page or source), which is expressed as the amount of KGS per one USD, on the relevant Rate Fixing Date, or if not available, then;
- (ii) The Calculation Agent shall then determine the Exchange Reference Rate on the following basis: The Exchange Reference Rate shall be the arithmetic mean of such firm quotes (expressed as the number of KGS per one USD) from four Reference Dealers as the Calculation Agent is able to obtain for the sale of KGS and the purchase of USD at or about 11.00 a.m. (Bishkek time) on the Business Day following the Rate Fixing Date, for settlement on the next Bishkek Business Day, provided however, that if fewer than four (but at least two) Reference Dealers provide such firm quotes then the Exchange Reference Rate shall be the arithmetic mean of the quotes actually

obtained. If none, or only one, of the Reference Dealers provides such a firm quote, then;

- (iii) The Exchange Reference Rate will be determined by the Calculation Agent in its sole discretion, acting in good faith and in an impartial and in a commercially reasonable manner in accordance with its normal procedures for determining such exchange rate (or a comparable exchange rate) at such time.

For the purposes of this Annex:

**“Bishkek Business Day”** means any day on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealings in foreign exchange and foreign currency deposits) in Bishkek.

**“Business Day”** means any day (other than a Saturday or Sunday) on which commercial banks and foreign exchange markets settle payments and are open for general business (including dealings in foreign exchange and foreign currency deposits) in New York City, London and Bishkek.

**“Calculation Agent”** means DLM Finance B.V. in accordance with the provisions of the Calculation Agency Agreement entered into between the Issuer and the Calculation Agent dated 23 October 2019 (as amended and/or supplemented from time to time). All references to the Calculation Agent shall include any successor or successors to DLM Finance B.V. as Calculation Agent in respect of the Notes;

**“Early Redemption Date”** means the date (if any) on which the Notes become due and payable pursuant to Condition 9;

**“Exchange Reference Rate”** means, in respect of a Rate Fixing Date, the USD/KGS rate of exchange, expressed as the amount of KGS per one USD as determined by the National Bank of the Kyrgyz Republic and published (i) on the NBKR Website, at approximately 1.00 p.m. (Bishkek time) on such Rate Fixing Date and/or (ii) on the Bloomberg page KGS NBKR Curncy (or any successor page) provided that in case of any discrepancy between the USD/KGS rate of exchange as published on the Bloomberg page and as published on the NBKR Website, the USD/KGS rate of exchange as published on the NBKR Website will prevail;

**“Rate Fixing Date”** means the date which is two Business Days prior to the applicable Fixed Interest Date, any Early Redemption Date or the Maturity Date, as applicable;

**“Reference Dealers”** means leading dealers, banks or banking corporations which regularly deal in the USD/KGS foreign exchange market, as selected by the Calculation Agent in its sole discretion, acting in good faith and in a commercially reasonable manner; and

**“Reference KGS Amount”** means KGS 8,413,020 per Calculation Amount, which is calculated using the initial USD/KGS exchange rate of KGS 84.1302 per USD 1 set on 28 April 2022.
